# **Privacy Policy**

  marketing communications (where permitted by law), and measure the
  effectiveness of our advertising campaigns. We may use third-party
  advertising partners.
- For Analytics and Research: To analyze how the Site is used, understand user behavior, and improve our services.
- **To Comply with Legal Obligations:** To comply with applicable laws, regulations, and legal processes.
- To full fill contractural obligation: To deliver agreed services and product as per contract.

#### 3. How We Share Your Information

We may share your information with the following categories of recipients:

- Service Providers: We may share your information with third-party service providers who assist us in operating the Site, processing payments, sending emails, providing customer support, conducting analytics, and delivering advertising. These service providers are contractually obligated to protect your information.
